About the Course

Screening and assessment of suicide risk in medical settings is crucial to providing safety and treatment to a suicidal patient. Suicide is the tenth-leading cause of death in the United States, ahead of both prostate cancer and automobile accidents. A devastating event for family, friends, and care providers, suicide is preventable. Because 50 percent of individuals who die by suicide see a medical provider within one month before their passing—often for treatment of depression—the issue of suicide prevention is of particular importance in the health care setting. Kaiser Permanente is committed to developing an evidence-based approach to preventing suicide in health care settings by systematically screening patients for suicide risk, providing structured assessment of those identified as being at risk, and following up with interventions that include crisis response planning, removal of lethal means, and integrated behavioral health care.

Objectives

At the end of this educational activity, participants will be able to:

- Restate the importance of suicide risk prevention in the health care settings.
- Restate the prevalence and risk factors for suicide for different patient populations (e.g., veterans)
- Assess patients for risk of suicide.
- Screen patients for depression using the PHQ9.
- Utilize the Columbia to screen for suicide risk.
- Integrate behavioral health screening into routine daily practice.
- Develop a crisis response plan for patients scoring 3 or higher on Columbia.
- Reduce imminent risk through removal of lethal means with patients and family members.
- Treat underlying conditions of depression, anxiety, and substance abuse disorders.
- Conduct suicide risk assessment and prevention with special populations (e.g., veterans)
- Manage the pathway of care of a depressed or suicidal patient.
- Implement a treatment plan through referral and resources.

Washington State Requirement

The state of Washington recently passed legislation (RCW 43.70.442) mandating that health care providers (physicians and physician assistants; osteopathic physicians and osteopathic physician assistants; licensed practical nurses, registered nurses, and advanced registered nurse practitioners; naturopaths; social workers, and mental health providers) receive a one-time 6 hours of training in suicide prevention.

Certified counselors, chemical dependence professionals, occupational therapists and assistants, and physical therapists and assistants, must receive a one-time 3 hours of training in suicide prevention.
